## **CLUBHOUSE RENTAL CONDITIONS**

 $\Box$  Do not disturb window treatments, windows cannot be covered.

 $\Box$  If damage to the clubhouse exceeds the amount of the security deposit, additional costs will be charged to the co-owner of record.

 $\Box$  Dancing is allowed only on the dance floor, not in carpeted areas.

 $\Box$  Music amplification and/or noise levels exceeding reasonable sound levels that disturb co-owners. surrounding the Clubhouse is unacceptable and can result in forfeiture of part of your security deposit.

□ Parking of cars by party guests in the lot at the rear of the Clubhouse is strictly prohibited. For large parties where space in the Clubhouse lot is insufficient, guests should be informed that parking is allowed on both sides of Torquay Avenue. *Note: Should your guests park in a restricted area, you may forfeit some or all of your security deposit fee.* 

 $\Box$  The rear exit doors of the Clubhouse are locked for security reasons and are to be used as an emergency fire exit only.

### $\Box$ NO HELIUM-FILLED BALLOONS.

 $\Box$  No furniture moved from floor to floor, no furniture on the dance floor.

 $\Box$  The library is not part of the rental space. Guests are not permitted to use the library.

□ The renter of Clubhouse is responsible for set up, including but not limited to table and chairs.

 $\Box$  Only Coventry residents, who are in good financial standing with the Association, will be allowed to rent the Clubhouse.

 $\Box$  A Coventry co-owner may rent the clubhouse on behalf of a non-resident, only if the co-owner accepts full responsibility and must attend the event full time.

□ Public invitations to events and money-making events are not allowed.

 $\Box$  100-person maximum capacity. The number of guests should not exceed the stated amount on the application. Please be as accurate as possible when stating the number of guests on your application.

□ No for-profit parties, political parties or sales parties.

 $\Box$  Nothing should be taped or pinned to walls or woodwork (i.e. balloons, posters etc.).

I (we) the undersigned agree to conform to the rules and regulations adopted by the Coventry ParkHomes Association to govern the Clubhouse and further agree to be financially responsible for any and all damages or stolen articles from the Coventry Clubhouse property which results from our rental.
